**NOSHA Receives Generous Donation!**

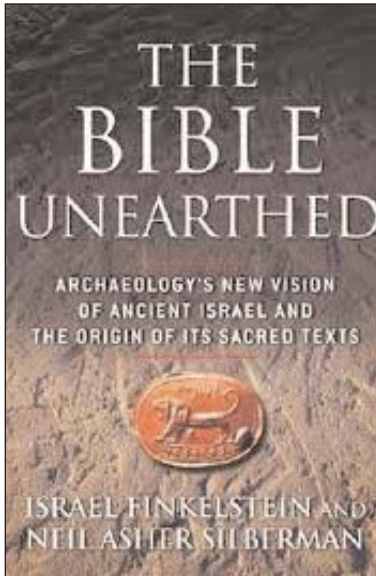
As with all non-profit organizations, NOSHA relies upon dues and donations for its operating expenses and costs of special events, out-of-town guest speakers and public awareness activities.

## **Summer Book Review: *The Bible Unearthed: Archaeology's New Vision of Ancient Israel and the Origin of Its Sacred Texts***

During most of the nineteenth century, secular scholars of the Hebrew Bible -what Christians call the Old Testament -- believed its contents were almost entirely folklore, with very little factual history. This assumption had to change, however, as the discipline of archaeology began to mature near the end of that



century. Inscriptions and artifacts began to show that there was real history in the Bible, at least in outline. The ancient city of Jericho, for example, turned out to be a real place, and its walls really did fall down, even if not quite how and when the Bible claimed. Well into the twentieth century, believers in Biblical historicity tended to claim vindication by what archae-

ologists unearthed.

After about 1970, though, claims of archaeological support for the historicity of the Hebrew Bible became increasingly difficult to make. Accumulating data required revisions to dates and changes to understandings of ancient cultures, leading to a new synthesis that was much more of a challenge to the Bible. An apt summary of this new synthesis can be found in *The Bible Unearthed: Archaeology's New Vision of Ancient Israel and the Origin of Its Sacred Texts*, written by **Israel Finkelstein** and **Neil Asher Silberman**, and published in 2001. While no interpretation of archaeological data is completely uncontroversial, these authors are qualified archaeologists and their synthesis has been well received by the archaeological mainstream, even if not universally accepted.

The main inference drawn by Finkelstein and Silberman is that much of the Hebrew Bible was heavily edited, adapted, and refocused during the seventh and sixth centuries BCE, long after the Exodus and the times of Joshua, David, or Solomon. The rewrites took place during two centuries marked by monotheistic reform, the destruction of Jerusalem, the exile of its elite to Babylon, and their later return to rebuild. The rebuilding of Jerusalem was not just physical, but was

also political and religious, and revamping sacred texts played an important role in establishing the new order. The new redaction was designed to promote worship of one God only, to establish Jerusalem as the only legitimate center of sacrifice, and to legitimate the territorial claims of the Davidic dynasty that was based there. Finkelstein and Silberman say this explains the many anachronisms, omissions, and exaggerations in Biblical lore.

The Exodus from Egypt could not have happened as described in scripture, Finkelstein and Silberman explain, because 600,000 and more people wandering in the Sinai for 40 years would leave clear archaeological remains, of which absolutely nothing can be found. Nor is there evidence of a military incursion of foreign Israelites into Canaan. Much more likely, the Children of Israel were one of many closely related Canaanite populations who only gradually distinguished themselves from their neighbors by territory and religious practice. While archaeology can confirm the existence of a Davidic dynasty beginning a little before 1000 BCE, it also indicates that the kingdom of Saul, David, and Solomon was nowhere near as large or opulent as the Bible describes, Jerusalem and Judah being rustic backwaters by the standards of those times.

Where the new archaeological synthesis does confirm Biblical content, it often supports details that Biblical literalists would rather not face. Most significantly, archaeology confirms the continued presence of polytheism among Israelites, as described extensively in the books of Kings and elsewhere. Figurines and other cult objects found throughout the kingdoms of Israel and Judah show that the general Semitic pantheon that Israelites share with Canaanites, Phoenicians, Assyrians, and others, was worshiped well into the sixth century BCE, the time of the final rewrite of Hebrew scripture. It is impossible to say when monotheism became one of the elements of the Israelite religious milieu, but it cannot have eradicated polytheism before the reconstruction of the Jerusalem Temple in 516 BCE, or even later.

Some readers will find *The Bible Unearthed* a bit too archaeological for their tastes. But anyone with more than a passing interest in what archaeology can tell us about the ancient Children of Israel will find it a worthy read.

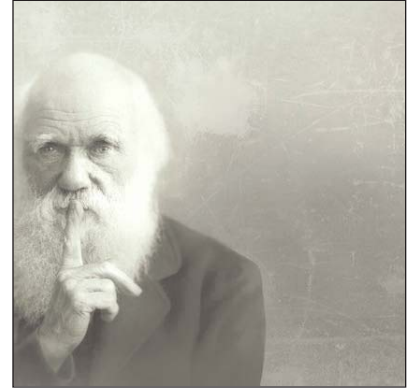

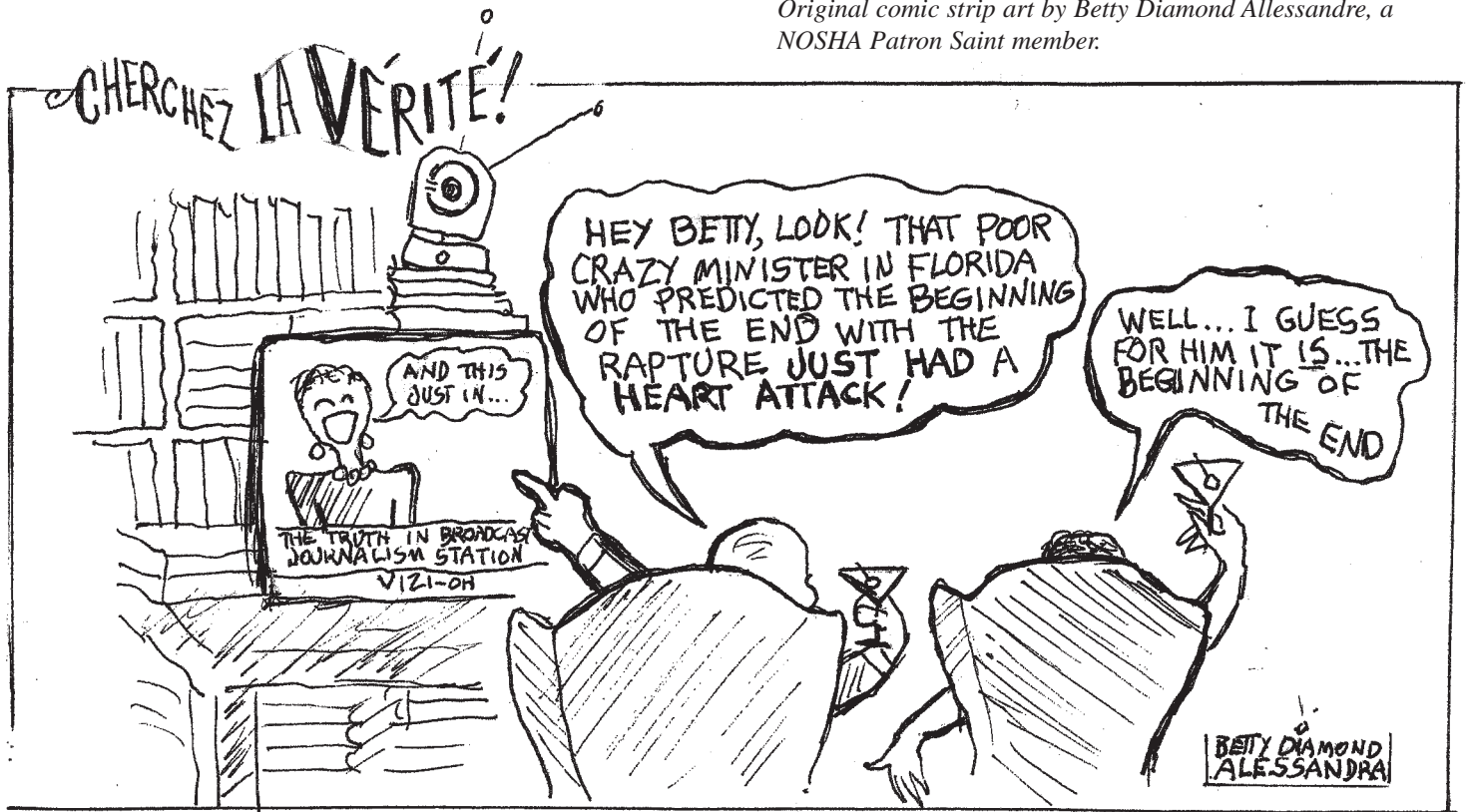

watering hole for some serious fun!

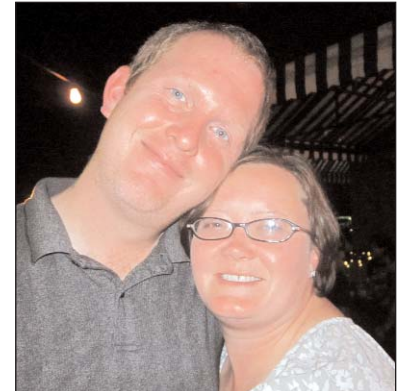

### Lawmakers ignoring history: Monday, June 13

Given Louisiana's fiscal difficulties, I would hope our legislators would work to solve existing problems rather than create new ones. But no, they've passed House Bill 277 to put a Ten Commandments monument at the Capitol. Tax dollars will now have to be spent defending this boondoggle from the predictable lawsuit.

There's nothing wrong with acknowledging the historical influence of the Ten Commandments in American culture. But the only discernible purpose for this monument is to promote the false notion that our legal system is based on the Bible, in spite of history, which shows the vast influence of secular humanism and the laws of ancient Greece and Rome.

### Time to get tough on wage theft in community: Sunday, June 19

A day's pay for a day's work. This is one of the most basic ideas of justice, shared by many different faith traditions. And yet for too many construction, restaurant and domestic workers in our community, wage theft is a reality. That is why we, as community religious leaders, are standing united to call on our City Council to pass a meaningful wage theft ordinance for New Orleans.

In April, the judges, constable and clerk of First City Court, with the encouragement of City Council members, created a new process of monthly one-day hearings for workers to allege wage theft.

A process was established for translators where needed and fee waivers for workers who cannot afford court costs. This is a good first step, and we take heart from the words of the City Council Resolution passed in support of the new process on April 7: "pledging to continue to work with all parties to seek additional effective instruments to address wage theft in New Orleans." In addition, Councilman Arnie Fielkow said, "We look forward to continuing to address wage theft in the most effective manner."

The most effective manner to address the justice issue of wage theft is a city ordinance on wage theft -- such as recently passed by the Seattle City Council, making wage theft a crime. Don't we all agree that it is indeed a crime, to take someone's money away from them? If done by a thug on the

street, we recognize it as a crime. Why isn't it a crime when done by a business owner or manager or contractor?

A day's work for a day's pay. It is simple justice. Our country's economy, and our city's recovery, depend on the productivity of all our workers. It is hard to be productive when one cannot be sure one will be paid for one's work.

We call on all religious people and all concerned community members to join us on this important issue of justice in our community.

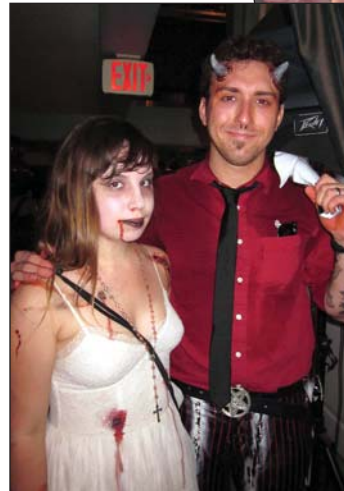
